_____ I understand that this is a construction project, and that install times are subject to weather conditions - please refer to the agreement for projected install timelines.

_____ I understand that it is my responsibility to apply for the Greener Homes Loan. Please refer to "Canada Greener Homes Loan" (CGHL) Guidelines on page 2.

_____ I understand there may be additional costs to my project if it includes a main panel upgrade, trenching, or if there is a backup generator for my home. The project will be reviewed by Shift and any changes to scope/price will be communicated to the client and will need to be accepted, prior to commencement of the project.

_____ I understand the basic functionality of solar as per the Shift solar FAQ webpage.

_____ I understand that if I do not meet the GHL criteria, I have the option to use the provided financing or seek alternative financing.

_____ I understand that my project lead time will not commence until I have signed the contract and fully paid the deposit.

_____ I understand that if my roof has less than 10 years of expected life that it is recommended that it gets replaced prior to installing solar. Shift has no liability if a roof leaks as a result of poor quality shingles.

_____ I understand that if my electrical panel is in a recessed wall or cabinet, drywall demo might be required to install a new subpanel, or when upgrading the main panel, if that is part of my project scope. If a main panel and meter upgrade is required, stucco damage may remain if applicable. Shift is not responsible for drywall, cabinet, or stucco repair. The project manager will discuss options with the customer prior to installation.

Canada Greener Homes Loan (CGHL) Guidelines

Step 1: Complete your pre retrofit energy evaluation by a licensed energy advisor. Our administration team will put you in touch with “EnergyGuy” who will contact you to book the evaluation. There will be a \$500 + GST cost for your pre retrofit evaluation and a \$300 + GST cost for the post retrofit evaluation. (There will be additional fees for multi-unit buildings).

Step 2: Once the evaluation has been completed and you have received your ten-digit Energuide file number you will have the ability to apply for the loan. Please note, wait times for receiving your completed report may take 2 weeks.

Step 3: Step 3: Visit <https://cghli.ca> and sign in or sign up depending what stage of the process you are currently in.

Step 4: Proceed with the registration steps outlined by the Government. It will require you to input your ten-digit Energuide file number.

Step 5: Once the application has been submitted it will be subject to the Government's timeline and approval eligibility to receive approval confirmation.

Step 6: Once the CGH Loan has been approved, please contact Shift & Firefly Solar by responding to the original welcome email that the loan has been approved so we can begin the process of planning your solar install.

Attention: It is very important to note that IF the installation takes place before your application and approval of the loan you will be INELIGIBLE to receive the funds and this cannot be changed.

Step 7: After the completion of your project and the inspection has taken place it is your responsibility to contact EnergyGuy to book the post retrofit evaluation.

Step 8: Once this is complete and you've received all of your receipts and documents you will be able to upload all of the required information into the Greener Homes loan portal. Once completed the funds for the Loan will be released in the following weeks.
